As we move into the Fall season, we are thankful for so much. Since I wrote the last perspective for <u>The</u> <u>Rancher</u>, we have seen many of our youth graduate high school and go on to further their education. With their departure, we have also seen new boys and girls take their places in our programs. In my 22 years with the Youth Ranches I have seen hundreds of young people come and go. I cannot tell you how proud I am of their resiliency in facing major life problems, setting goals for themselves and then achieving those goals.

In June, Live Oak was deluged with 20 inches of rain in a two day period by Tropical Storm Debby. Although we sustained no major damage at the Boys Ranch, our Thrift Store in Live Oak was flooded with eight inches of water throughout the whole building. We lost most of our furniture along with some appliances, clothing and other items on the sales floor. We have had to tear down walls and begin restoration in the worst hit areas of the store. Our thrift stores are an important part of our revenue stream and we appreciate those who helped us with repairs as well as restocking the sales floor with good donated items.

On a happier note, our Summer Camps were a great success. Hundreds of underprivileged boys and girls spent a week at the Youth Camp in Barberville and Caruth Camp in Inglis. Thousands more attended week long mobile day camps in their home communities. As our staff worked side by side with Sheriffs' Deputies, these young people experienced our theme that "Law Officers Are Your Friends." Through a week of fun activities and educational experiences, they learned some important life lessons about respecting themselves and others.

As a donor and supporter of the Youth Ranches, you are a big part of all we do to help Florida's children live healthier and more productive lives. The investments made in these young lives will continue to pay dividends for many years to come.

Imagine what it takes to feed hundreds of kids, counselors and cops each and every week of Summer Camp! Fueling children of all sizes each day for swimming, hiking, sports, crafts, canoeing, games, singing and all the other high energy summer camp activities is an amazing feat. Cases of meat, vegetables, eggs, milk, bread, and so much more stream through our kitchens as we prepare well balanced, filling meals for all to enjoy.

And while many of our faithful donors across the state provide the financial support to help with these expenses, the kids have to do their fair share to make each meal successful. Every day, two youngsters from each campsite are designated as "table setters." They arrive 15 minutes before mealtime and proceed to set the table for their group. While this may seem like a simple task, many of our kids have never set a table before. We have a handy model attached to the wall so the campers can learn where each utensil should be placed.

We eat "family style" at camp so once grace is said and everyone is seated, the "table setters" bring the serving dishes full of food from the kitchen to the table. You can always tell a camper's best buddy as the favor-

ite dish of the meal will be placed in front of that camper so he or she can go first.

After dinner, the dishes are cleared, the table is cleaned and camp songs begin! With motions, movement and music, mealtime often brings out the biggest smiles of the day. As everyone exits the chuckwagon, they must stack their chairs away from the table and one campsite per day stays behind to sweep up and mop as necessary.

Chores like this teach our children basic manners and values. We learn to care for and respect each other as we share food and fellowship. We express thanks for what we are given and pitch in to make everyone feel welcome and comfortable.

Kudos to the cooks at Camp who take such good care of our kids and hooray for our donor family who make sure our boys and girls have three square meals and snacks every day. "My older brother has been in some trouble and he used to take his anger out on me. I tried to fight back but it was tough. My dad needed help, too. It was better for me to come here. When I get older and bigger, I want to get back together with my family," Keegan added. "Even if they tried to hurt me, I still love them."

For the past six months, Keegan has lived in Saunders Cottage with nine older brothers and two loving Cottage Parents. "It's pretty good so far," he said confidently. "I feel safe!" He added, "Mom is a great cook, too!" When asked about his favorite dish, he replied, "Well, I can't tell you because I haven't tried all of them yet!"

At 11 years old, Keegan likes Legos, bike riding and playing basketball with the older Ranchers. "The big boys let me play point guard because I am so fast," he claims with a mischievous grin!

Things in his world are remarkably good, but Keegan is still working on a few issues as he adjusts to life on the Ranch. "Controlling my temper is getting better, but I still need to be more truthful," he stated matter-of-factly. "There is still work to be done."

Keegan also understand that the Boys Ranch is supported by our donor family. He said, "It's pretty cool that people give money and other stuff for us. They are so nice. I can't believe they are thinking about helping a kid like me. Sometimes I write a note just to say 'thanks'. I hope they get it because I really mean it."

Keegan may be one of our younger boys, but he is beginning to understand what it means to be safe and loved. He is able to enjoy just being a boy growing up on a Ranch with brothers, and bikes and basketball.

Many teenagers today are lazy and carry a sense of entitlement that they "deserve" things that are not earned. At the Florida Sheriffs Boys Ranch, we try to raise our teens with a different perspective in life. One of the attributes we instill daily in our Ranchers is a strong work ethic. We want them to learn the value of a day's wage for a day's work and experience

the personal satisfaction of a job well done.

There are many jobs available on the Ranch so every teenager has a chance to earn some money and explore vocational interests. Work sites at the Boys Ranch include the farm, gym, office, school, chapel, maintenance or mechanics shop. Each teen must complete an application, go for a job interview and then perform at a satisfactory level before they can be considered for a promotion. Additional training and guidance is given along the way so the youth can grow in knowledge, skills and abilities.

If a young man applies for a job in grounds maintenance, he will first shadow a staff member performing the duty. Next, he will be given a



mower and is now learning to master a riding radial mower.

operating a push mower on a specific part of the property. As the young man excels in his assignments, he will be given more responsibility such as operating a riding mower or weed eater. He must demonstrate he can handle this step up and complete the job on time and to his supervisor's satisfaction.

Progressing forward, work sites like the farm offer higher paying jobs but also require additional education and experience. For instance, all youth who work with the tractors, must be 15 years of age or older, pass a written test, a driving test and walk through the explanation of the equipment. He must demonstrate an understanding of the inherent dangers of using the equipment and attend monthly general safety meetings. When we see

a young man driving a tractor, we know he is a reliable, responsible young man with a strong work ethic.

Some Ranchers also seek to enhance their work experience by becoming a Crew Chief. These boys have proven their work abilities and now have a Rancher or two working with them on certain projects. The Crew Chief takes a lead role and helps the other boys stay on task. Some of the jobs completed by work crews include repairing fence lines, loading hay bales, and picking up limbs and branches around the campus. While staff are nearby, a sense of independence, autonomy and confidence grows as these young men begin to learn how to work as a team and complete a job successfully.

Each step in our vocational development program teaches our teens the importance of arriving on time, being respectful, accepting feedback, and completing assignments with quality and pride. Furthermore, as they earn a paycheck, they are learning about money management and building self esteem and self sufficiency. We want them to leave us with a strong work ethic and the confidence and basic abilities to obtain and retain a job. We proudly watch them succeed year after year as they enter the work force and earn their way to a brighter future.




